The Tibetan Cultural Center is happy to announce that vending space will be available during His Holiness the Dalai Lama's visit to Bloomington in May 2010.

Currently, the available space will accommodate only 20 vendors, so assignments will be made on a **first-come/first served basis to the first 20 vendors who send completed applications and checks**. We are still working with the University to secure additional space to accommodate additional vendors.

Subject to approval by the State Department Security, vendors may sell merchandise on May 11 (4:00 p.m. to 7:00 p.m.), May 12 (7:00 a.m. to 10:00 p.m.) and May 13 (7:00 a.m. to 3:00 p.m.). The vending tent will be in the parking lot south of the IU Auditorium at 7th Street and Jordan, on the Indiana University Campus. It is adjacent to the IU Auditorium where His Holiness the Dalai Lama will be giving teachings.

The Tibetan Cultural Center will provide the following:

- Large tent with soft sides that can be rolled up during the day or kept down for rainy weather.
- 8 x 10 booth space (two 8 foot tables and two chairs)
- Lighting during evening hours
- IUPD (Indiana University Police Dept.) security from 7:00 p.m. – 7:00 a.m.
- Set-up and take down of tables

The cost of booth space is \$400.00

By signing below, vendors agree to the following:

- ✓ Vendors will be responsible for getting merchandise to and from the tables
 - Set up begins at approximately 1:00 p.m. on Tuesday, May 11th
 - Tables must be vacated no later than 3:30 p.m. on Thursday, May 13th
- ✓ The Tibetan Cultural Center can not be responsible for damage or theft of merchandise.
- ✓ The Tibetan Cultural Center is not responsible for merchandise in case of rain
- ✓ The Tibetan Cultural Center cannot receive or store shipments of merchandise.
- ✓ No camping is permitted
- ✓ No food vending is permitted
- ✓ No refunds will be made for cancellations received after May 1, 2010.

Location of table space will be determined by a lottery draw. This will take place Tuesday, May 11th at 12:00 noon at the vendor tent. Vendors are encouraged to be present at the draw.
